ORDER

In compliance to order of Hon'ble High Court, Himachal Pradesh, Shimla, in the matter of CWP No. 189 of 2004 dated 06.04.2004 Northern International Educational & Research Centre Society Vs Himachal Pradesh University, Shimla directing NCTE to pass the order that *Sharan College of Education, Kangra, Himachal Pradesh applying to NCTE, NRC, Jaipur, by enclosing a copy of the order along with the application, NCTE, NRC, Jaipur shall pass a formal order extending / granting recognition to the petitioner's institution for the academic session 2004-2005 on the same lines as was done in the Order dt. 23rd Oct., 2003 because of the reasons and facts and circumstances detailed in this judgement. Subject to petitioner's aforesaid application reaching NCTE, NRC, Jaipur within two weeks from today, the NCTE, NRC, Jaipur shall pass the aforesaid order on the aforesaid lines and communicate the same to the petitioner within a period of two weeks thereafter, accordingly, this order is issued herewith.*

However, the Order No. NRC/NCTE/F-3/HP-77/2002/5102 dt. 23.10.2003 issued by NRC, NCTE, Jaipur granting the recognition to Sharan College of Education, Kangra, Himachal Pradesh for B.Ed. course with an intake of 100 seats from the session 2003-2004 itself implies that the institution will stand recognized for forthcoming academic sessions until and unless the recognition is withdrawn by the NCTE by issuing an Order under Section 17(1) of NCTE Act, 1993.
